3. **Pet Health:** The owner warrants and represents that the pet is healthy and in good physical condition. Upon request by the company, the owner will provide a veterinarian's certificate confirming the pet's health. The owner is responsible for any and all veterinary fees incurred prior to the pickup of the pet. If veterinary services are required during travel, the company will take the pet to the nearest veterinary service location and provide them with the contact information of the primary veterinarian and the owner for service questions and payment. All Service fees are the owner's responsibility.

4. **Care and Liability:** The company will make every effort to care for the pet while being transported. However, the company assumes no responsibility whatsoever for injuries, sickness, death, or other disabilities which may occur to the pet while being transported. The owner, in consideration of the company's agreement to transport the pet, hereby irrevocably and completely releases the company and its officers, directors, shareholders, employees, contractors, agents, attorneys, and drivers from any and all liability, claims, suits, demands, and judgments of any and every kind resulting from or in any way connected with the transportation of the pet and any harm, injury, sickness, or death which may befall the pet while being transported by the company.

5. **Behavior and Responsibility:** The owner warrants and represents that the pet is neither dangerous nor aggressive. The owner shall be completely financially responsible for any damage to property, to humans, or to other animals caused by the pet while being transported and shall promptly pay all damages on demand. The owner shall indemnify and hold harmless the company and its agents from any claim or loss resulting from such damage. In the event a pet becomes aggressive during transportation, the company reserves the right to place the pet in a crate/kennel/containment at the owner's expense.
